Hi,

Here's the summary of activity to date. We did 26 last evening. We also had a discussion and made some decisions re: two groups

1) DCIS/NT: we have been reviewing the pathology reports as we go along re: these results. If they were previously diagnosed as DCIS we have been notifying the region, but not paneling the person, as the ER PR result does not impact treatment of people with this type of cancer.

The others will require the slides, interpretations and clinical history to be paneled with a group of pathologists and oncologists to see where the discrepency lies. When the regular panel has completed the entire list, this will be done

2) "Retro" convertors: this group are ones that were actually ER/PR positive but have come back form Mount Sinai as ER/PR negative. These will require review of both our slides and Mount Sinai slides as well as the clinical history of the patient. We have 5 in this group right now that will be deferred to the end of the paneling so they can be done as a group. Along with this five are four others that, although had a degree of positivity when originally staianed were considered clinically as negative, so they were not treated. All four have been considered as confirmed negative and contacted.
