JOAN DAWE: As part of the terms of the resignation there were provisions for severance. That severance was agreed upon with Mr. Tilley and approved by the board and the minister of Health and Community Services.

CAROLYN STOKES: Joan Dawe is chair of Eastern Health's board of directors. She wouldn't discuss the details of the package but it's been reported that Mr. Tilley will receive his full year's salary worth \$255,000. He will also receive other benefits and can collect unused paid leave.

LORRAINE MICHAEL: But I don't see this kind of a package for somebody who has resigned. So that's what makes me question. That's what smells fishy. If he got this kind of contract because he resigned, then I think one has to ask well does that mean that his resignation was asked for. It certainly is a kind of package that one negotiates when a resignation
