Hi,

It's looks like Ms. [REDACTED] (from [REDACTED]) was not a cancer clinic patient and did not have much contact with us at all except for her ER/PR which we did and reported in 1998

Ms. [REDACTED] (also from [REDACTED]) saw a Dr. [REDACTED] in 1997 after her diagnosis (maybe only twice though)

Ms. [REDACTED] is a patient of Dr. [REDACTED]

In regards to the group of 14 and the Group of 16:

- The group of 14 is really only 12 as there are only 13 listed and one of them is in the 16 group.
- The group of 16 is only 8 as 8 of them are really positive and wouldn't be retested.
- There is another one on the list that NLCHI is referred to contact carbonear (#16 on list 3).
- There is also one that says she was deleted by dr. Cook off the original list, but no further description...I'll check with him today
- One of the group of 13 (#58) of list 2 is not deceased and does not need to be called because she has been calling nancy
- Of these recently identified, if the person is deceased, I would recommend that we contact the families when we write to the deceased, when the results come back. If we can go by the NLCHI sources... (which we know made one mistake), then 5 of the 12 are deceased....meaning we only have to call 6 (as one has been in contact with nancy)

Also on list #3 I don't know why #2 and #3 were on the original list...but Terry referred them to Western...if they were on our list, Western had to have told us, so why would we send them back to western.....
