Hi,

1. [REDACTED] was not followed by the Cancer Clinic, so we have no additional information on her.
2. [REDACTED] was diagnosed in 1997 and was treated with Tamoxifen for 5 years. She was originally ER neg, PR <5.
3. [REDACTED] was informed about the retesting in December 2005. The results did not change and no treatment change was required and this was disclosed to her in November 2006 by Dr. Ganguly. NLCHI asked us about her before; the questioned why the specimen was sent for retesting and not another. Our reply to them was that the best specimen was sent. **AS FAR AS I CAN DETERMINE NO OTHER SPECIMEN HAS BEEN SENT SO HER NAME SHOULD NOT BE HERE.**
4. [REDACTED] was on Tamoxifen. In May 2006 [REDACTED] noted that, although she was ER negative, she had not been retested so he "filled out a pathology requisition" for that and started her on Femara pending the results. Although there is no notation of results, she carried on with the Femara. There are no retesting results in Meditech and I will check to see if they were ordered directly from Carbonear and reported there. She is not on the list to Mount Sinai and Terry noted to NLCHI that she was retested in May 2006. **I WILL FOLLOW UP ON THIS, BUT IF SHE HAS BEEN RETESTED SHE SHOULDN'T BE ON THIS LIST**
5. [REDACTED] is noted in OPIS to be deceased, with a date of death as September 18, 1999. She is on the list of deceased patients being retested
6. [REDACTED] does not appear to have been retested. She has been sent for retesting, but I'm not sure how she was identified as being missed. She is from St. John's. **WE HAVE NOT IDENTIFIED HER AS NEEDING TO BE INFORMED ABOUT RETESTING EITHER.** She may have called Nancy, I will check.

10. [REDACTED] was a resident of [REDACTED] and is listed in OPIS as Deceased. The date of death is September [REDACTED] 2002. She is on the list of deceased patients being retested

I'll follow-up on #4 and #6 and get back to you.....If you have ordered [REDACTED] chart let me know?

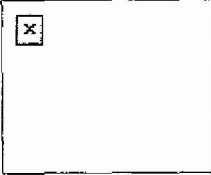
