1 given the state that the work is at, we’ve
 2 prepared a supplemental list of documents that
 3 contains the materials that we’ve collected
 4 yesterday. That will be here in about half an
 5 hour, so that co-counsel can review it. It
 6 contains about 40 documents that are new as a

 18 yourself what the exact status of that is.

20 Q. Thank you. Mr. Pritchard?

21 MR. PRITCHARD:

22 Q. Good morning, Commissioner. I’ve advised co-
 23 counsel this morning that as of this morning
 24 the work that we’ve been doing is about 95
 25 percent complete. And as a result of the--

 3 anticipate that that work will be completed
 4 this morning?

15 Q. Commissioner, as well, since Tuesday, having
 16 reviewed the e-mails that Mr. Pritchard had
 17 forwarded to co-counsel, Commission co-counsel
 18 Monday, late Monday night, yes, late Monday
 19 night, Commission co-counsel decided that
 20 further interviews would be necessary or re-
 21 interviews, in certain instances, and they
 22 have begun and, in fact, will continue today.

1 Q. You'll appreciate, of course, that I haven't
 2 seen or Ms. Chaytor has seen the approximately
 3 40 documents that Mr. Pritchard just referred
 4 to. What I'm going to suggest is as follows
 5 is that because, of course, review of those

 7 interviews are not going on.

 12 right now, assuming that there's nothing that
 13 requires further inquiry, before we can
 14 conclude the examination of Mr. Ottenheimer.
 15 I'm assuming that for the moment. I'm going
 16 to suggest that we resume at 9:30 tomorrow
 17 morning with a view to continuing with Mr.
 18 Ottenheimer. I say that, I certainly hope
 19 that that's the case, that we're able to do
 20 that, but I had assumed the same thing on
 21 Monday afternoon when we adjourned.

23 Q. So, do I take it then you're suggesting that
 24 barring information arising in the documents
 25 which are to be revealed today, which cause
