Hi there Peter, I understand you are on holidays and I hope you are enjoying. I was trying to touch base with you re the latest media coverage related to our ER/PR review. As you are probably aware, there has been some recent coverage involving a patient, Mrs. Lewis and her lawyer, Ches Crosbie. We cannot comment specifically about this case, for confidentiality reasons, just to say her case was a part of our review. I just wanted to update you with the latest information and offer any further clarification/information you might need. The update is as follows:

- 1069 cases have been reviewed by Mount Sinai. The vast majority of these patients have been notified of the results of the review. As there were several physicians across the province involved with meeting with these patients, we are now verifying with them all that the patients have been contacted, but we are very confident that most, if not all of them, have been contacted
- Any results received from Mount Sinai indicating that the status of the report has changed (ie the specimen was originally reported as ER/PR negative and upon review is reported as positive) are reviewed by an expert panel consisting of surgeons, pathologists and oncologists. This expert panel reviews each case and makes a recommendation for any further treatment / follow up to the physician deemed to now be responsible for the patients care...this can be a surgeon/oncologist or other. This recommendations is sent in a letter to the most responsible physician and the patient is contacted and followed up by the latter.
- As a part of the review of over 1000 charts we have identified a small number of cases that require further follow up not related to ER/PR status, but an issue detected as a by product of the original investigation. We are in the process of notifying these patients and finalizing any recommendations related to this. <u>As you know, any review of this</u> magnitude will result in identification of issues that we might not have been otherwise aware of
- We are working to have the review and follow up with patients completed by the end of the summer. Then we will be in a position to analyze and summarize the results of our review and any changes we have implemented or plan to implement as a result of this.
- Throughout this process, we have been committed to disclosure and attention to the needs of our patients. We will continue with this focus.
