Barry and I met vesterday am and reviewed the DCIS list. The first comment I must make is that I'm don't know why this list is identified as that.

Of the 52 patients on the "DCIS" list only 27 are confirmed DCIS.

Of the remaining:

- There are 8 that have no results in Meditech. Barry is following up on that this week
- There are 15 that were initially returned from Mount Sinai as DCIS; and then reviewed here, subsequently retested and now have values reported in Meditech
 - Of those are two that are conversions that I don't feel have been dealt with. One is the case I emailed earlier this week. I need direction on those two, I assume they will need to be paneled
 - I will review the others (confirmed negative) and ensure the results have been disclosed
- There are 2 patients whose review by Eastern Health has a different conclusion then that of Central.
